The Bidder may also submit a proposed add or deduct price for an alternate manufacturer for each item on the list, which price shall remain in effect for 60 days after executing the Agreement. The lowest Base Bid shall be determined without consideration of alternates proposed by the Bidder.

In the event that alternate equipment is accepted by the Owner, the Contract Price shall be increased or decreased by Change Order in the amount of the price differential quoted by the Bidder in the space provided on this list.
