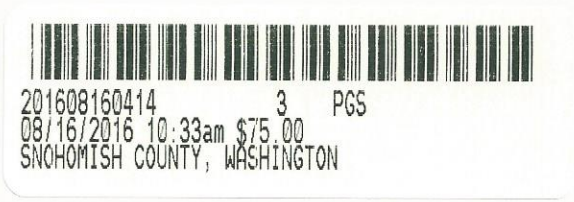

That portion of the Northeast Quarter of the Northwest Quarter of Section 28, Township 31 North, Range 5 East W.M. described as follows:

Beginning at the Northeast corner of said Northeast Quarter of the Northwest quarter;
thence West along the North line thereof 290 feet to the true point of beginning;
thence continue West along the North line of said Subdivision 127 feet;
thence South 342 feet;
thence East 127 feet;
thence North 342 feet to the true point of beginning;


