#### DECLARATION

KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED OWNER OF FEE SIMPLE TITLE TO THE LAND HEREIN DESCRIBED, DO HEREBY DECLARE A BINDING SITE PLAN WITH RESPECT TO SAID LAND PURSUANT TO REVISED CODE OF WASHINGTON 58.17.040171 AND CITY OF ARLINGTON UNIFIED DEVELOPMENT CODE; DECLARE THIS BINDING SITE PLAN TO BE THE GRAPHICAL REPRESENTATION OF THE SAME, AND DECLARE AND ESTABLISH THE FOLLOWING COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS WITH RESPECT TO SAID LAND.

L DEVELOPMENT ACCORDING TO SITE PLAN. ALL DEVELOPMENT AND USE OF THE LAND DESCRIBED HEREIN SHALL BE IN ACCORDANCE WITH THIS BINDING SITE PLAN. AS IT EXISTS OR IS HEREAFTER AMENDED WITH THE APPROVAL OF THE CITY, AND IN ACCORDANCE WITH SUCH OTHER GOVERNMENTAL PERMITS, APPROVALS, REGULATIONS, REQUIREMENTS AND RESTRICTIONS THAT MAY BE IMPOSED UPON SUCH DEVELOPMENT AND THE USE THEREOF. UPON COMPLETION, THE IMPROVEMENTS ON THE LAND SHALL BE INCLUDED IN ONE OR MORE CONDOMINIUMS OR OWNED BY AN ASSOCIATION OR OTHER LEGAL ENTITY IN WHICH THE OWNERS OF UNITS THEREIN OR THEIR OWNER'S ASSOCIATIONS HAVE A MEMBERSHIP OR OTHER LEGAL OR BENEFICIAL INTEREST. THIS BINDING SITE PLAN SHALL BE BINDING UPON ALL THOSE WHO NOW OR HEREAFTER HAVING ANY INTEREST IN THE LAND DESCRIBED HEREIN

2. EASEMENT FOR INGRESS AND EGRESS DECLARANT, ITS SUCCESSORS, ASSIGNS, BUSINESS INVITEES, LICENSEES, TENANTS AND THEIR GUESTS SHALL HAVE AN EASEMENT OF INGRESS AND EGRESS OVER AND ACROSS ALL ROADWAYS AS DELINEATED ON THIS BINDING SITE PLAN OR AS CONSTRUCTED ON THE LAND SUBJECT THERETO, THE OWNER(S) OF THE LAND SUBJECT TO THIS BINDING SITE PLAN SHALL MAINTAIN AND KEEP IN GOOD REPAIR THE ROADWAYS, FIRE LANES AND PARKING AREAS SITUATED ON SAID LAND AND SHALL KEEP SUCH ROADWAYS, FIRE LANES AND PARKING AREAS FREE OF SNOW, ICE, RUBBISH AND OBSTRUCTIONS OF EVERY NATURE, AND SHALL PROVIDE ADEQUATE DRAINAGE AND SHALL MAINTAIN ANY DRAINAGE FACILITIES LOCATED ON THE SUBJECT FRUPERTY.

3. RECREATIONAL FACILITIES AND COMMON SITE FEATURES. AS DELINEATED ON THIS BINDING SITE PLAN OR AS CONSTRUCTED ON THE LAND SUBJECT THERETO, THE RECREATIONAL FACILITIES (IF ANY) AS WELL AS ALL COMMON SITE FEATURES AND AREAS (INCLUDING LANDSCAPING, ACCESS, PARKING, UTILITIES, SEWER AND DRAINAGE SYSTEMS AND GREENBELT EASEMENTS, BUT EXCLUDING RESIDENTIAL BUILDING SITES AND LIMITED COMMON ELEMENTS ALLOCATED TO CONDOMINIUM UNITS) SHALL BE FOR THE MUTUAL AND NON-EXCLUSIVE USE OF THE OWNERS, TENANTS AND GUESTS OF ALL LAND SUBJECT TO THIS BINDING SITE PLAN. THE OWNERS OF THE SUBJECT PROPERTY SHALL OPERATE, STAFF, MAINTAIN, REPAIR, INSURE AND IN ALL WAYS BE RESPONSIBLE FOR ANY SUCH RECREATIONAL FACILITIES AND COMMON SITE FEATURES.

4. MULTI-PURPOSE EASEMENT. DECLARANT HEREBY GRANTS A NON-EXCLUSIVE EASEMENT OVER AND ACROSS SAID LAND FOR INGRESS AND EGRESS AND OVER AND ACROSS OTHER EASEMENTS, ROADWAYS, AND UTILITY LINES SPECIFIED IN THE BINDING SITE PLAN OR ESTABLISHED IN OR ON SAID LAND AND IMPROVEMENTS THERETO. SUCH RESERVATIONS ARE FOR THE PURPOSE OF COMPLETING, AND THEREAFTER USING AND OPERATING, ALL PHASES OF DEVELOPMENT OF SAID LAND! AND PURSUANT TO RCW CHAPTER 64:34, CREATING EITHER A SINGLE CONDOMINIUM OR TWO OR MORE SEPARATE CONDOMINIUMS. THE EASEMENTS RESERVED HEREUNDER SHALL ENTITLE THE DECLARANT, OR ITS SUCCESSORS, TO TIE INTO WATER, SANITARY SEWER, STORM SEWER AND ROADWAYS SUBJECT TO THE REQUEST OF THE NECESSARY APPROVALS FROM THE CITY OF ARLINGTON. CONNECTION TO ELECTRICAL, GAS, TELEPHONE, OR OTHER UTILITY LINES OF ALL VARIETIES WILL REQUIRE THE APPROVAL OF THE RESPECTIVE UTILITY COMPANY. DEVELOPED AND EMPLACED ON SAID LAND.

5. MULTI-PURPOSE MAINTENANCE, EXCEPT AS OTHERWISE PROVIDED BY LAW, AND EXCEPT TO THE EXTENT MAINTENANCE IS PERFORMED BY A PUBLIC OR PRIVATE ENTITY PROVIDING UTILITY SERVICE, ALL PRESENT AND FUTURE OWNERS OF THE LAND SUBJECT TO THIS BINDING SITE PLAN SHALL MAINTAIN AND REPAIR ALL ROADWAYS, PARKING AREAS, UTILITIES AND DRAINAGE FACILITIES, RECREATIONAL FACILITIES AND OTHER COMMON SITE FEATURES AND AREAS.

6. GOVERNMENT EASEMENT. ANY GOVERNMENTAL ENTITY HAVING JURISDICTION OF THE LAND SUBJECT TO THIS BINDING SITE PLAN AND THE IMPROVEMENTS THERETO. AND ANY PUBLIC OR PRIVATE ENTITY PROVIDING UTILITY SERVICE THERETO, SHALL HAVE A NON-EXCLUSIVE EASEMENT FOR INGRESS AND EGRESS OVER AND ACROSS SAID LAND FOR THE PURPOSE OF INSPECTION, MAINTENANCE AND REPAIR.

7. NOTICES, ANY DEMAND TO BE MADE UPON OR ANY NOTICE HEREUNDER TO BE GIVEN TO THE OWNER OR OWNERS OF THE LAND SUBJECT TO THIS BINDING SITE PLAN SHALL BE IN WRITING AND MAILED, POSTAGE PREPAID, CERTIFIED MAIL RETURN RECEIPT REQUESTED, TO THE LAST KNOWN MAILING ADDRESS OF SAID

8. ENFORCEMENT, THE PROVISIONS OF THIS BINDING SITE PLAN (AND THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS HEREIN) ARE DECLARED TO CREATE MUTUAL AND EQUITABLE COVENANTS AND SERVITUDES FOR THE BENEFIT OF THE DECLARANT, EACH FUTURE OWNER OR CONTRACT PURCHASER, AND THEIR SUCCESSORS IN INTEREST. ENFORCEMENT OF THESE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS MAY BE BY ANY PROCEEDING AT LAW ON IN EQUITY AGAINST ANY PERSON OR PERSONS VIOLATING OR ATTEMPTING TO VIOLATE ANY COVENANT, CONDITION, RESTRICTION, OR EASEMENT EITHER TO RESTRAIN VIOLATION OR TO RECOVER DAMAGES. FAILURE OF THE DECLARANT OR ANY SUCCESSOR IN INTEREST TO ENFORCE ANY COVENANT, CONDITION, RESTRICTION OR EASEMENT, OR EXERCISE ANY RIGHTS HEREIN CONTAINED, SHALL IN NO EVENT BE DEEMED A WAIVER OF THE RIGHT TO DO SO THEREAFTER. ALL COSTS INCURRED IN THE ENFORCEMENT OF THESE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS, INCLUDING A REASONABLE ATTORNEYS FEE, SHALL BE BORNE BY THE NONPREVAILING PARTY. INVALIDATION OF ANY ONE OF THE PROVISIONS HEREOF BY JUDGMENT OR COURT ORDER SHALL IN NO WAY AFFECT ANY OTHER PROVISIONS HEREOF BY JUDGMENT OR COURT ORDER SHALL IN NO WAY AFFECT ANY OTHER PROVISIONS HEREOF BY JUDGMENT OR COURT ORDER SHALL IN NO WAY AFFECT ANY

9. THE CITY SHALL HAVE AN EASEMENT FOR ACCESS ALONG AND OVER ACCESS WAYS AND PARKING AREAS TO ALLOW POLICE, BUILDING, FIRE AND PUBLIC WORKS DEPARTMENT ACCESS TO THE PROPERTY AS WELL AS FOR PROVIDING EMERGENCY AND LAW ENFORCEMENT SERVICES AND EASEMENT FOR UTILITIES OVER AND UNDER SUCH ACCESS WAYS.




