

# Plat of Wuthering Heights Section 10, Township 31 N., Range 5E. W.M.

City of Arlington, Washington Snohomish County, Washington

## Legal Description

That portion of the West 10 acres of the Southeast quarter of the Southeast quarter of Section 10, Township 31 North, Range 5 East, W.M., lying southerly of Portage Creek;

EXCEPT County road known as 204 th Street N.E.

(ALSO KNOWN AS Lot 4 of Short Plat 160 (5-84) recorded under Auditor's File No. 8406220350).

#### Easement Provisions

An easement is hereby reserved for and dedicated to the City of Arlington, Public Utility District No. 1 of Snohomish County, General Telephone Company of the Northwest, Inc., and the franchised television cable company, and to their respective successors, and assigns, each on a non-exclusive basis, under and upon the exterior seven (7) feet of all lots, parallel with the adjoining street frontage, in which to install, lay, construct, renew, operate and maintain underground conduits, cables, and wires with necessary facilities and other equipment for the purpose of serving this subdivision and other property with electricity, telephone, cable t.v., water, sewer, storm drainage and any other utility which is reasonable and necessary for a residential subdivision.

#### Restrictions

No lot or portion of a lot in this plat shall be redivided and sold except in conformance with R.C.W. Chapter 58.17, and all applicable zoning and ordinances of the City of Arlington.

Following origional reasonable grading of roads and ways hereon, no drainage water on any lot or lots shall be diverted or blocked from its natural course so as to discharge upon any public road rights of way to hamper proper road drainage. The owner of any lot or lots, prior to making any alteration in the drainage system after the recording of the plat, or prior to connecting the drainage system required as part of any: construction on said lot to the existing drainage system, must make application to and recieve approval from the city of Arlington, for any: alteration of or connection to the existing drainage system. Any enclosing of drainage waters in culverts or drains or rerputing thereof: across any lot as may be undertaken by or for the owner of any lot shall be done by and at the expense of such owner.
