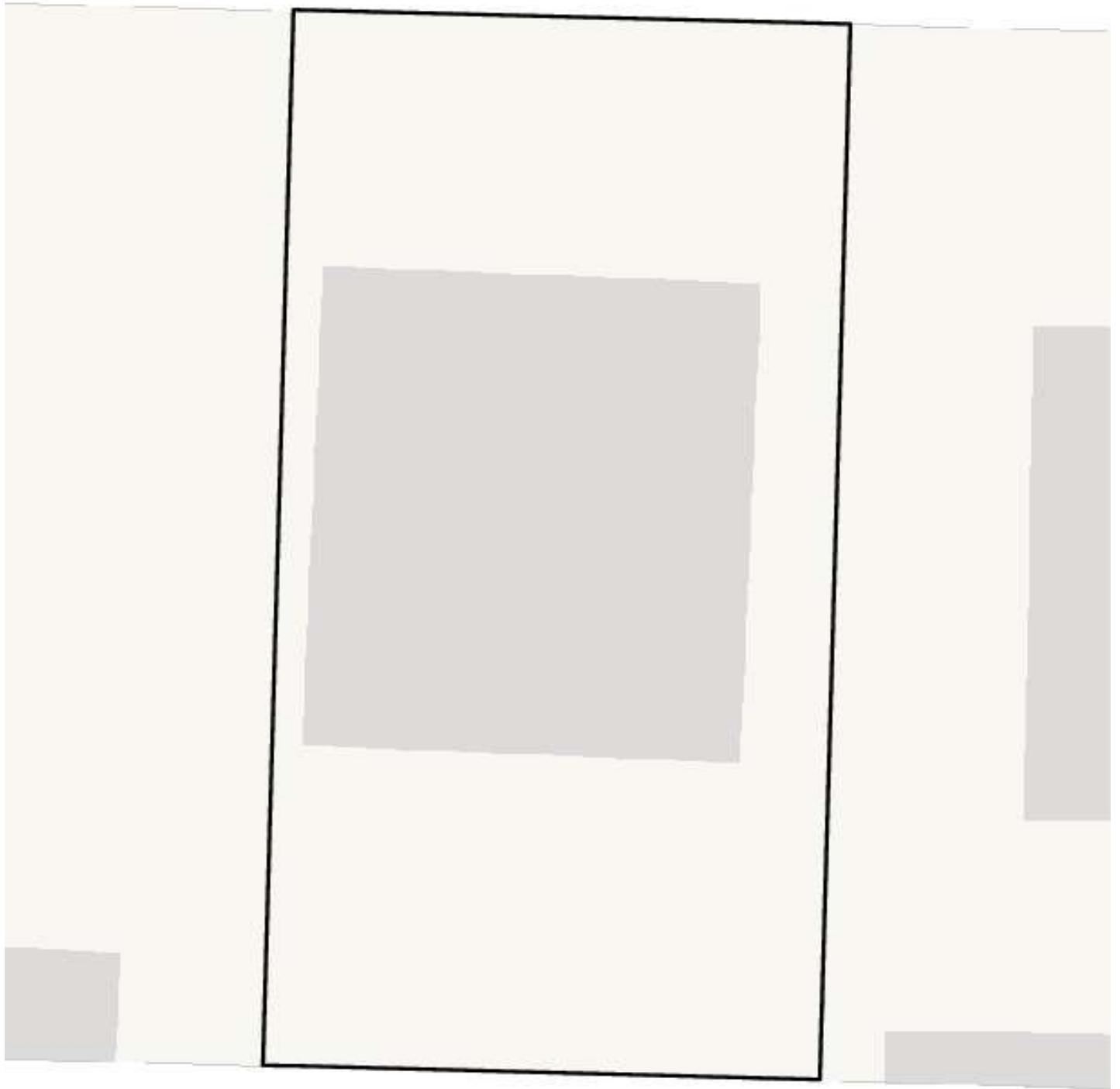



CRITICAL AREAS MAP






